You are correct, you are entitled to import personal purchases outside of the EUTR, since legislation states that the placing on the market of timber or timber products applies to commercial activities- i.e. along the lines of your "Personal use and not for Resale for Profit". You should make sure that any personal imports are clearly addressed to you as a person (rather than in the company name) – here's a starting point for the HMRC point of view.
